**WRAWBY PARISH COUNCIL**

The Minutes of the Meeting of Wrawby Parish Council held in the Village Hall on Tuesday 14<sup>th</sup> May 2019.

**PRESENT:** Messrs I R Smith, W T Richardson, R G Green, Mrs K Rothery, Mrs L Tandon, and Mrs P Bosanquet.

Also present were 2 members of the public.

Three Ward Councillors, Cllrs N Sherwood, C Sherwood and R Waltham attended part of the meeting.

**APOLOGIES FOR ABSENCE** - Apologies were received from Messrs M Hebblewhite and M Reddish (both working away) – later apologies were received from Mrs K May (illness).

**DECLARATION OF INTEREST** - None from attendees, but M Reddish had declared an interest in the planning matter covering the Kettleby Lane application and his interest was therefore noted.

**MINUTES:** - The Minutes of the Meeting held on 5<sup>th</sup> March 2019, having been circulated, were approved for adoption.

**MATTERS ARISING:** -

1. The Clerk confirmed that the new salt bin for Applefields had been delivered and was being stored by Mrs Tandon
2. The Clerk confirmed that the £13000 precept monies had now been credited to Council's account.

Details re applications etc. had been circulated to members and other than the application at item 12, there were no matters to be discussed at the meeting.

### **VILLAGE HALL**

1. The caretaker confirms that there should be disposal bins in the ladies toilets for disposal of sanitary products. Mrs Day, having been given permission to speak by the Chairman, confirmed that she is in discussion with Tulip Healthcare to establish a service agreement for this. Later Now confirmed, the agreement has been set up.
2. Mrs Day confirmed that the floors in the toilets have deteriorated and an estimate has been obtained for their replacement/covering.

### **ELECTIONS - 2019**

The Clerk gave details of the results of the Parish Council and Ward elections. Nine of the previous Parish Councillors were automatically re-elected and council has received authority to co-opt a tenth member – the Clerk is attending to this.

With regard to the Ward elections, Messrs Sherwood, Sherwood and Waltham were re-elected after the election.

At this point the N Lincs Councillors (Messrs Sherwood, Sherwood and Waltham) joined the meeting and the Chairman took the opportunity to congratulate them on their re-election.

### **PERSON OF THE YEAR**

The Clerk had noted all the nominations received so far and voting slips were given to all councillors who then returned them to the Clerk. After amalgamating these with the prior nominations, Mrs Susan Day was selected at this year's "Wrawby Person of the Year".

Mrs Day was present and expressed total amazement.

The Cup, which Mrs Day will receive at the August Horticultural Show, was displayed by Mrs Rothery and all councillors were impressed.

### **PLANNING APPLICATION - LAND NEXT TO "THE WILLOWS,BARTON ROAD"**

At this point N Lincs Cllr N Sherwood left the room – he is Chairman of the Planning Committee.

This application was discussed at length and the unanimous feeling was that Council should object most strongly to this application for the following reasons:

- (a) The application once again falls outside the Building Line

- (b) The application is for an area of open countryside
- (c) Wrawby's infrastructure is already at breaking point (school, no shop, traffic) and this will only add to the pressure.
- (d) The application will destroy a wildlife haven.

#### **NORTH LINCS COUNCILLORS**

Cllr Waltham (N Lincs) confirmed that the 5 Year land supply was now complete and this may affect future planning decisions.

He also advised Council that the village grass cutting work was being devolved to local works and an advice would shortly be received.

#### **MATTERS FOR FURTHER DISCUSSION**

Cllr Richardson noted that all the low villages (Worlaby, Bonby etc.) had similar village signs at the entry to the villages and feels that Wrawby would benefit from following suit. The Clerk will look at this and report back.

The Chairman advised council that he has been in touch with the Church authorities with regard to the dangerous condition of the Church roof. After much contact, the Church of England is looking at the situation and hopefully matters will progress.
