The Minutes of the Meeting of Wrawby Parish Council held in the Village Hall on Tuesday 7th January 2020.

APOLOGIES FOR ABSENCE - Apologies were received from Mr M Reddish and Mr M Hebblewhite (both working away).

DECLARATION OF INTEREST - None

MINUTES: - The Minutes of the Meeting held on 19th November 2019, having been circulated, were approved for adoption.

MATTERS ARISING: -

1. Cllr Richardson confirmed that he had attended the Course held by N Lincs Council on Code of Conduct matters and that he had found it helpful.

He re-emphasised the importance of Declaring an Interest in appropriate matters.

2. Mrs Rothery had stated her concerns regarding ambulances speeding through the village at her last meeting. A technical reply has been received from the Ambulance Service but Mrs Rothery continues to worry that an accident may occur that an accident may occur if ambulances continue to speed through the village with no warning siren applied.

PLANNING MATTERS/APPLICATIONS

Details re applications etc. had been circulated to members and there were no matters to be discussed at the meeting.

CORRESPONDENCE: -

There has been an e-mail from Diane Coult on behalf of the Sleigh Group, further to her e-mail 2 months ago – about the possibility of the “village green” etc. being lit at Christmas, using electricity possibly from a nearby lamp standard. Cllr Sherwood had sought Highways information on this and had replied to Diane’s original e-mail - Council were of the opinion that this matter had therefore been investigated fully. Council again discussed the matter and felt that there is little more that Council can do.
